DIRECTIONS FOR USE

Wet the surface with water. Dilute Sardex Green with water maximally to a ratio of 1:5. Apply the product using a brush, cloth, or brush. Let the product soak in for about 20 to 30 minutes. Rinse off thoroughly with water.

APPLICATION CONDITIONS

Minimum ambient temperature : 5 °C Maximum relative humidity : 100% Minimum surface temperature : 5 °C Maximum surface temperature: 35 °C

CLEANING OF EQUIPMENT / SPILLS

Rinse with clean water immediately after use.
